The Company intends to follow the ASX CGC P&R in all respects other than as specifically provided below.

The independent directors of the Company are Mr Peter Clare, Mr Peter Pawlowitsch and Mr Gerard Bongiorno. When determining the independent status of a Director the Board used the Guidelines detailed in the ASX Corporate Governance Council's Principles of Good Corporate Governance and Best Practice Recommendations.
